Introductory remarks: IG in the focus

- Internet: complex, evolving ecosystem equilibrium
- IG issues may influence equilibrium, e.g.:
 Self-regulation vs. control
 Principles vs. regulations
 Security vs. privacy
 Economic, social impact
 IT regulations and the Internet, etc.
- Meetings in 2012- 2013: ICANN, CSTD/ECOSOC, Cyberspace Conference, IGF, WCIT, UNGA, WSIS+10 WTPF, etc. – part of learning curve



WSIS Review Process

- UNGA 67/195 December, 2012
 Reaffirms the role of the GA in the overall review of the implementation of the outcomes of the WSIS, to be held by the end of 2015, and decides to consider the modalities for the review process by the end of 2013;
- UNESCO Paris, February 2013
 WSIS+10: Towards Knowledge Society: sessions on IDN,
 Enhanced Cooperation, Principles, Content, Multilingualism
- ITU/UNESCO/UNCTAD/UNDP May, 2013
 WSIS Forum: Ministerial Round Table, High Level Dialogue;
 Thematic Workshops; Action Line Facilitator Meeting, etc.
- ITU Sharm el Sheikh April 2014 WSIS+10 review meeting

Enhanced Cooperation - Tunis Agenda

- 69. We further recognize the need for EC in the future, to enable governments, on an equal footing, to carry out their roles and responsibilities, in international public policy issues pertaining to the Internet, but not in the day-to-day technical and operational matters, that do not impact on international public policy issues.
- 71. The process towards EC, to be started by the UN SG, involving all relevant organizations by the end of the first quarter of 2006, will involve all stakeholders in their respective roles, will proceed as quickly as possible consistent with legal process, and will be responsive to innovation. Relevant organizations should commence a process towards enhanced cooperation involving all stakeholders, proceeding as quickly as possible and responsive to innovation. The same relevant organizations shall be requested to provide annual performance reports.



EC Background - Consultations

- 2006 Nitin Desai, UN SG Special Adviser Informal consultations – No agreement
- 2008 UNSG invited 10 organizations to report on EC progress
- 2010 UN USG convened a multi-stakeholder consultation
- 2012 UNCSTD Chair conducted a multistakeholder consultation




CSTD WG on Enhanced Cooperation

UNGA Resolution 67/195 (2012)

- "invites the Chair of CSTD to establish a working group on enhanced cooperation to examine the mandate of WSIS regarding EC, through seeking, compiling and reviewing inputs from all Member States and all other stakeholders, and to make recommendations on how to fully implement this mandate;"
- report in 2014



Multi-stakeholder Model





- Mandate
- Multi-stakeholder approach
- Mutual trust
- Results based on consensus
- Observers ECOSOC rules apply
- Constraints (time, resources, venue, etc.)



- Preliminary consultations (on-line)
- Physical meetings in Geneva:
 1st meeting: 30 May (P.M)-31 May 2013
 3 or 4 further meetings in 2013 (3 days each)
 1 further meeting in 2014 (February 2014)
- Chair's report & recommendations: 28
 February 2014



WGEC Preliminary Consultations

- Define objectives based on WSIS Tunis Agenda and relevant UN Resolutions
- Identify topics related to EC (cyber security, principles, examples of EC, capacity building, etc.)
- Agree on topics to be discussed result oriented approach
- Agree on schedule

WCIT-12 Treaty

- Issues: Update of ITRs (1988) & Internet
- Preamble: recognize the right of access of MSs to international telecommunication services
 vote & not concensus!!!
- **ITR**s
 - do not address the content-related aspects of telecommunication
 - unsolicited bulk electronic communication
 - charging and accounting
- Resolution: To foster an enabling environment for the greater growth of the Internet

- 6 draft opinions agreed
 - Promoting Internet Exchange Points (IXPs)
 - Capacity-building for the deployment of IPv6
 - IPv6 Adoption/deployment; transition from IPv4
 - Enabling environment for Broadband and development
 - Support for multi-stakeholderism in IG
 - Operationalizing the Enhanced Cooperation Process
